Genesis Recovery

Representative Shawn Conley, for Genesis Recovery project, addressed the council concerning the new facility. Jack Conway was able to provide a way for funding of \$500,000, with \$300,000 being for the purchase of the property on CW Stevens Blvd. by the City and then be donated to Genesis Recovery. Expectation of completion of the project is the end of 2015.
