Call to Order

Mayor Steele called the meeting to order at 5:00 p.m.

Roll Call

Department Reports

Building Inspector/Code Enforcement

Mr. Lands was unable to attend the meeting due to a family illness. His report showed the following activity.

- Update on condemnation orders

Also 9 different yards/lawns have been mowed by the Street Department

Councilperson Nash asked for the Council to consider taking action on the abandoned house on the corner of Landsdowne and College Street. The owner has been deceased for several years and the city has been the mowing of the yard. Chris Allen confirmed the street dept will be mowing the yard tomorrow.

Attorney Glass stated council could legally take action under the city condemnation ordinance.

Mr. Glass stated to have Kirkland Lock Service to open the house. Mr. Glass and Chief McDavid with Code Enforcer John Lands will inspect the interior condition at that time.

Emergency Management

Roger Dunfee state the emergency drill at Smithfield's Ham Plant was very successful. He and Joanne were updating the Emergency Response list. Also he and Joanne will be attending the quarterly Emergency Management in Prestonsburg tomorrow.

Street

Chris Allen stated the department had been patching potholes as of late. He was advised by Councilperson Nash that National Drive needs a deep pothole fixed.

Discussion was held on the view obstruction on Armstrong Street. Mr. Allen was instructed to speak with the landowner concerning the cutting of the hedge.

Fire

Chief Greg Felty presented the monthly activity report. The report reflected 45 calls answered in the month of June. He announced the new SUV truck had been ordered and would be ready for pick up in 12 to 14 weeks.

Police

The monthly activity report distributed out by Chief Kevin McDavid showed over 2200 calls answered in June. He also stated the 2 new cruisers will be in 8 to 10 weeks.

Parks and Recreation

Attorney Glass presented a draft of the deed for the property behind the jail. He asked council to look it over and if they approve he would send it to the County Attorney. Council agreed to forward the document to the county attorney. Discussion was held on the parks and setting closing times. Also summer help would be needed once the 40 acre park is open to aid in the mowing and upkeep.

Section 5.2 Times beverages by the drink can be sold currently 11 am to midnight Monday-Saturday

To extend the hours of sale to 2 a.m. on 2 special holidays

March 17th, St. Patrick's Day

December 31st, New Years Eve

Attorney Glass will research the issue if the holiday stated above falls on a Saturday.

Mayor's Report

Mayor Steele announced the State approved 2 applicants for the sale of liquor. Dionysus and Grayson Beverage Centre were approved.

Mr. Steele stated the street department had begun to work on the drainage issue on 4th Street.
