# Presentation of Excellence Achievement Award Becky Burton

May is the month of Children's Mental Awareness being recognized by Pathways, with Becky Burton at the overseer of the campaign. Mayor Steele presented Ms. Burton with a Proclamation of Acheivement for her work with Mental awareness program.

# **Visitors**

## **FIVCO**

Gail Melvin presented a Programs and Referenced Handbook to the city council. This program will provide the grants and programs available to the city and other organizations. Mrs. Melvin conducted a brief scenario of the 3 ring binder given to the City Clerk. Mrs. Melvin confirmed FIVCO would assist in the grant writing process for free since the City is a member.

# **Nellie Jordan of the Carter County Library**

Ms. Jordan presented a drawing showing the design to complete the 2<sup>nd</sup> floor of the branch on the east end. She stated the library will receive in the amount of \$275,000 to complete the project. Once the upstairs is done this area will host the East End Adult Education Center which will also provide local GED testing.

Nellie confirmed the City of Olive Hill has recently committed to donating \$18,000 for the next 3 years. With that being said, Ms. Jordan asked the same support from the City of Grayson.

# Ed Caudill of Papaw's Chuck Wagon

Mr. Caudill addressed the Council on the service his group provides to the public. His group serves residents living at River Run, Town Branch, Logan Trace, Popular Plain and Stovall Apartments He ask the city to contribute financial aid to their mobile soup kitchen fund. His expense for utilities and fuel is about \$1,100.00 per month. He stated he is not asking for the full amount, just what the Council feels comfortable with. Jennifer McGlone, member of the Meals on Wheels board addressed the council. She confirmed the Meals on Wheels program is still providing food service to the residents of Grayson with food being prepared at the Carter Nursing Home.

Mayor Steele stated the new budget would have to be carefully looked at before any commitment could be made. Council thanked Mr. Caudill with for the work he does.

### Mindy Woods of Planning and Zoning

Mindy Woods announced Jack Harper will be appointed to the Planning and Zoning board within the next few days.

# **Mobile Home Restrictions**

- (1) The Planning and Zoning are requesting the change for mobile home replacement in the R-3 Zone and the grandfathered R-1 and R-2 mobile homes. The board suggested 2 years from the date of construction. Council felt 2 years was too restrictive and felt 5 years would be better.
- (2) Mobile Home not being used as an office space unless designed to be used as such. This has become an issue in recent years.

Mindy distributed a copy of the additional changes the Planning and Zoning requested. These changes include keeping structures to be kept in repair by several means and to keep the lawn manicured at all times.

Attorney Glass stated these changes will require 2 readings in ordinance form.

# **Department Reports/Requests**

## **Code Enforcement**

John Lands was unable to attend the meeting but was able to issue a report. His monthly report shown 4 requests, update on 6 notices of complaints and notice of condemnations.

### **Emergency Management**

Joanne Dunfee provided Council with a monthly activity report. Most of the activity was directed at the county flood victims.

#### Street

Chris Allen was in attendance for any questions the Council may have. Blacktopping advertisement will be soon.

Mayor Steele confirmed the maintenance building backside is dropping in the river.

#### Parks & Recreation

Discussion was held on getting 10 picnic tables for the walking trail park. Also the City has been approved for a \$10,000 tree grant for the small park. This will be completed by the end of June.

The City has applied for a \$15,000 GRANT and will hopefully know is we were approved in a few weeks.

#### **Police**

Chief Kevin McDavid presented Council with the department activity report for April. Total calls for the month was 1319, with 183 citations issued including 3 DUI's.

He announced the advertisement for an impound sale will be in next week's paper. Also he was granted permission to go to FIVCO to apply Homeland Security Grant funds to purchase various video equipment.

Councilperson Nash commended the Officers for not having issues like in other cities.

#### Fire

Chief Greg Felty distributed the monthly activity report for the Fire Department. Twenty-two calls were for the total for April with 11 inside the city limits.

The annual Firemen dinner will be held on Friday before Memorial Day.
